No collection charges shall be paid in case the airline fails to pay the UDF invoice to CCSIA within the credit period of 15 days or in case of any part payment.

- iv. **Exemptions in Payment of User Development Fee (UDF)** - In terms of DGCA AIC No. 14/2019 dated 16.05.2019 and AIC No. 20/2019 dated 06.11.2019 (decision of Ministry of Civil Aviation, Govt. of India vide order no. AV 29012/39/2018-AD dated 30.10.2019) the following categories of persons are exempted from levy and collection of UDF:
- Children (Under the age of 2 years)
 - Holders of Diplomatic Passport.
 - Airlines crew on duty including sky marshals and airline crew on board for the particular flight only (this would not include Dead Head Crew, or ground personnel),
 - Persons travelling on official duty on aircraft operated by Indian Armed Forces.
 - Persons travelling on official duty for United Nations Peace Keeping Missions.
 - Transit/transfer passengers (this exemption may be granted to all the passengers transiting up to 24 hours from arrival into airport and is part of the same ticket, in case 2 separate tickets are issued it would not be treated as transit passenger)

18.1.2. General Conditions

- All the above Airport charges (Landing, Parking and UDF) are exclusive of applicable taxes and shall be payable to Lucknow International Airport Limited.
- All the charges to Indian Carriers (including international operations) will be done in INR terms and to international carriers in USD terms.
- For all the above charges (Landing, Parking and UDF), the Airlines will be allowed a credit period as may be decided by LIAL from time to time.
- All the above Charges are excluding GST. GST at the applicable rates is payable in addition to the above charges
- Aviation Security Fee (ASF) (previously Passenger Service Fee (PSF) - Security) shall be applicable as prescribed by Government of India from time to time.
- Flight operating under Regional Connectivity Scheme will be exempted from charges as per Order No. 20/2016-17 dated 31.03.2017 of the Authority from the date the scheme is operationalized by the Gol as amended from time to time.

Definition of Category:

- Existing flights: Flights that are currently being operated at Lucknow
- New Route: A flight to a new destination that is currently unserved from Lucknow by any airline already operating at Lucknow. (Destination must be unserved for the previous 36 months) to / from regions of Africa, Europe/US and Far East.

E.g. Airline A introduces a new route Lucknow-Male, which is currently unserved from Lucknow by any airline.

Validity

The VTP for applicable international flights is valid from the date of commencement of operations and for the duration of 36 months for new international route.

Notes:

- No discount over and above the Variable Tariff Plan is applicable.
- VTP is applicable only for scheduled passenger and freighter airlines, as applicable in the table above.
- Scheduled airline must operate VTP eligible flights for (a) a minimum of 42 weeks within a rolling 12-month period; and (b) ensure strict slot adherence on laid down parameters of the Airport Operator, to qualify for the incentive.
- The payment of landing charges should be done by the airline in full without any deductions, as per the invoicing by LIAL. The settlement shall be provided in the form of a 'Credit Note' at the end of each 12-month period.
- LIAL reserves the right to change any term or condition of this VTP, withdraw or replace any of the category, at any time at its absolute discretion, by way of prior approval of AERA.

In the matter of Multi Year Tariff Proposal(MYTP) and Annual Tariff Proposal(ATP) for FY2019-20 & FY2020-21 Of the Second Control Period in respect of M/s Air India Air Transport Services Limited (AIATSL) for providing Ground Handling Services at Amritsar, Bhubaneshwar, Chandigarh, Goa, Jaipur, Patna, Pune, Varanasi & Lucknow International Airports.

- 1) M/s AIATSL is a subsidiary of Air India Limited and provides the services of Ground Handling at various Indian Airports. The Authority vide its Order No. 18/2019-20 dated 22.11.2019 determined tariff for Kolkata, Mumbai, Guwahati, Cochin, Ahmedabad & Calicut Airport for FY2019-20 and FY2020-21. The Authority is yet to determine tariff for Amritsar, Bhubaneshwar, Chandigarh, Goa, Jaipur, Lucknow, Patna, Pune and Varanasi Airport.
- 2) M/s AIATSL submitted their MYTP/ATP for the complete Second Control Period (FY2016-17 to FY2020-21) online on 24th June, 2016. The increase in tariff sought by M/s AIATSL for FY2019-20 is 13% and for FY2020-21 is 2% year on Year on the existing tariff. Further M/s AIATSL vide their letter dated 20.09.2019 submitted the Annual Compliance Statement (ACS) for FY2016-17, FY2017-18 and FY2018-19 for all the major airports. M/s AIATSL has submitted the consolidated Balance Sheet for FY2016-17, FY2017-18 and FY2018-19. M/s AIATSL has submitted the bifurcation of financials (Balance Sheet for FY2016-17, FY2017-18 and FY2018-19) among all its stations where AIATSL is operating. M/s AIATSL has submitted the existing tariff/rates prevailing at above mentioned airports.



- 3) The services rendered by AIATSL for providing Ground Handling facility at above mentioned Airports are aeronautical services in terms of section 2(a) of the Airports Economic Regulatory Authority of India Act, 2008 (Act) and under section 13 (1)(a) of the Act, the Authority is required to determine tariff for aeronautical services
- 4) The Authority in accordance to the provisions of Chapter V of the AERA Guidelines) and since all the above mentioned airports are **"Non-Material"** the Authority vide CP 15/2019-20 dated 17 Jan, 2020 decided that the tariff will be determined under **"Light Touch Approach"** for the duration of Second Control Period (01.04.2016 to 31.03.2021).
- 5) The Authority observed that M/s AIATSL for the above mentioned airports has requested for 13% increase in tariff for FY2019-20 and 2% increase (year on year) for FY2020-21.
- 6) The Authority noted that M/s AIATSL has not conducted the stakeholder consultation with the users on the proposed ATP submitted for FY2019-20 and FY2020-21.
- 7) The Authority considered the submissions made by AIATSL and issued the Consultation Paper No. 15/2019-20 dated 17th Jan, 2020, wherein, the Authority proposed the following:

- 8) Further, the Authority proposed that the tariff charges for Non-schedule operations provided by the service provider should not exceed the ceiling rates approved by AERA for its scheduled operations for its similar class of aircraft.
- 9) The Authority noted/evaluated that a one-time increase of 13% for Chandigarh and Jaipur stations (FY2020-21), will earn a profit margin of 16% to 20%. For remaining above mentioned stations, although M/s AIATSL is making a reasonable profit margin (ref. para 7 above), a 2% increase in tariff is allowed by Authority for FY2020-21, considering the current trend of increase in inflation and cost of labour.
- 10) The Authority requested written feedback, comments and suggestions from stakeholders on the above Consultation Paper by 6th Feb, 2019. It is informed to all the concerned that none of the stakeholder has commented on the above mentioned Consultation Paper. Since none of the stakeholder has commented or have objections on the proposed tariff displayed vide above mentioned CP, the Authority approves/allows M/s AIATSL to charge tariff accordingly.

ORDER

Upon careful consideration of material available on record, the Authority, in exercise of powers conferred by Section 13(1)(a) of the AERA Act, 2008, hereby orders that:

- (i) The Service for ground handling being provided by M/s AIATSL for the above mentioned subject airports are **"Non-Material"**. Hence, the



Authority will adopt “**Light Touch Approach**” for tariff determination for the duration of Second Control Period (01.04.2016 to 31.03.2021).

- (ii) The tariff for 4th and 5th tariff year (i.e. FY2019-20 & FY2020-21), for ground handling services provided by M/s AIATSL at above mentioned subject airports is determined, as at **Annexure –I**. The determined tariff is applicable from the date of issue of tariff order to 31.03.2021.
- (iii) As regards to Non-Scheduled operations of scheduled operators, M/s AIATSL should not exceed the tariff charges as approved by AERA for its scheduled operations for similar class of aircraft.
- (iv) Tariff determined as above will be maximum tariff to be charged excluding statutory taxes, if any. No other charge is to be levied by M/s AIATSL over and above the approved tariff.
- (v) The Authority directs M/s AIATSL to conduct Users Consultation with stakeholders in accordance to AERA Guidelines on the proposed ATP, in future, before approaching AERA for Tariff determination.

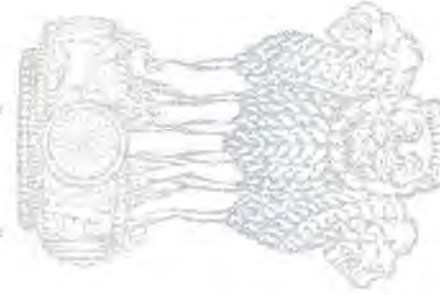

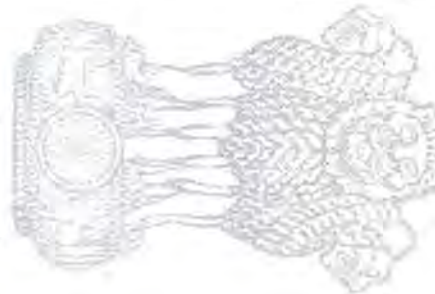

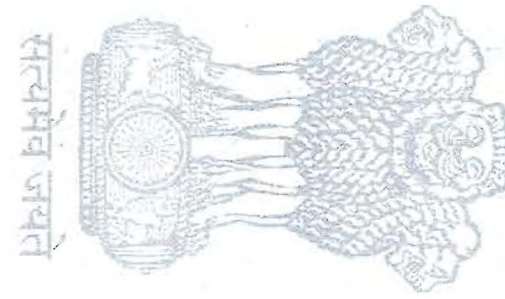

The Concession Agreement of CSC for Courier Cargo Services at Mumbai airport is valid only till 31.07.2021.

2. The Authority is in receipt of MYTP/ATP submissions for the 3rd Control Period (FY 2021-26) from some of the Independent Service Providers for Fuel Farm/ITP services. These proposals are currently under scrutiny and Consultation Papers will be issued shortly. Further, MYTP/ATP submissions for the 3rd Control Period (FY 2021-26) in respect of Cargo Handling / Ground Handling services have not been received from many ISPs.

Considering the above, the Authority, expects that the tariff determination process for the aforesaid service providers is likely to take some time. Hence, in the interim, the Authority, has decided that the Independent Services Providers as per above list,

except M/s CSC, Mumbai (at s.no.22 in the list), may be allowed to continue the levy of the existing tariffs, applicable as on 31.03.2021, for a further period of six (06) months w.e.f. 01.04.2021 to 30.09.2021 or till determination of tariff(s) whichever is earlier.


In the case of M/s CSC, Mumbai (at s.no.22 in the list), providing Courier Cargo Services at Mumbai Airport, the Authority observed that their Concession Agreement with the Airport Operator MIAL is valid only till 31.07.2021. Accordingly, the Authority, has decided that M/s CSC, Mumbai, may be allowed to continue the levy of the existing tariffs, applicable as on 31.03.2021, for a further period of four (04) months w.e.f. 01.04.2021 to 31.07.2021 or till determination of tariff(s) whichever is earlier.

ORDER

3. In view of the above, to avoid any regulatory vacuum in respect of the tariffs being levied by the regulated entities, the Authority, in exercise of powers conferred by Section 13(1) of the Airport Economic Regulatory Authority of India Act, 2008 hereby orders that:-

- (i) The **Independent Service Providers as per above list (Sl. No. 1 to 57 of table except M/s CSC, Mumbai listed at s.no. 22)** are allowed to continue levy of existing tariff, applicable as on 31.03.2021, for a further period of six (06) months **w.e.f. 01.04.2021 to 30.09.2021** or till determination of tariff by AERA for the relevant control period (for 2nd /3rd Control Period, as applicable) whichever is earlier.
- (ii) **M/s Cargo Service Centre (CSC), Mumbai**, is allowed to continue the levy of the existing tariff, applicable as on 31.03.2021, for a further period of four (04) months **w.e.f. 01.04.2021 to 31.07.2021** or till determination of tariff for 3rd Control Period whichever is earlier.
- (iii) The Airport Operators may ensure timely submission of proposals by Independent Service Providers at the respective 'major' airports and also ensure compliance of the Order.



**The Concession Agreement of M/s Concor Air Ltd. for provision of Domestic Cargo Services at Mumbai Airport is valid till 31.12.2022.*

2. The Authority is in receipt of MYTP/ATP submissions from some of the Independent Service Providers/ Airport Operators in respect of services relating to Cargo and Ground Handling. These proposals are currently under various stages of tariff determination process. However, MYTP/ATP submissions from some ISPs / AOs are yet to be received.



3. Considering the above, the Authority, expects that the tariff determination process for the aforesaid service providers is likely to take some time. Hence, in the interim, the Authority, has decided that the Independent Service Providers / Airport Operators as per above table, except M/s Concor Air Ltd. (at s.no.16 in the list), may be allowed to continue the levy of the existing tariffs, applicable as on 30.09.2022, for a further period of six (06) months w.e.f. 01.10.2022 to 31.03.2023, or, till the determination of regular Tariffs by AERA for their respective control periods, whichever is earlier.

In the case of M/s Concor Air Ltd. (at s.no.16 in the list) providing Domestic Cargo Services at Mumbai Airport, the Authority notes that their Concession Agreement with the Airport Operator MIAL is valid only till 31.12.2022. Accordingly, the Authority decides that M/s Concor Air Ltd. may be allowed to continue the levy existing tariffs (as on 30.09.2022) for a further period of three (03) months w.e.f. 01.10.2022 to 31.12.2022.

ORDER

In view of the above, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that: -

- (i) The **Independent Service Providers / Airport Operators** providing services relating to Cargo and Ground Handling at the various Major Airports as listed in table above, except M/s Concor Air Ltd. (at Sl.no.16 in the list), are allowed to levy the existing tariff, applicable as on 30.09.2022, for a further period of six (06) months **w.e.f. 01.10.2022 to 31.03.2023**, or, till the determination of regular tariffs by AERA for their respective control periods, whichever is earlier.
- (ii) **M/s Concor Air Ltd. (at s.no.16 in the list)**, is allowed to continue the levy of the existing tariff, applicable as on 30.09.2022, for a further period of three (03) months **w.e.f. 01.10.2022 to 31.12.2022**.
- (iii) The Airport Operators shall ensure timely submission of MYTPs/ATP by the concerned Independent Service Providers at the respective 'Major Airports'.
- (iv) The Airport Operator to ensure compliance of this Order.

3. The Authority is in receipt of MYTP/ATP submissions from some of the Independent Service Providers/ Airport Operators in respect of services relating to Cargo handling, Ground Handling & Supply of Fuel to the Aircrafts. These proposals are currently under various stages of tariff determination process. However, MYTPs from some ISPs/ AOs are yet to be received.

4. Considering the above, the Authority, expects that the tariff determination process for the aforesaid service providers will take some time. Hence, in the interim, the Authority decides that the Independent Service Providers/ Airport Operators, as per above Table 1, may be allowed to continue the levy of the existing tariffs, applicable as on 30.09.2023, for a further period of six (06) months w.e.f. 01.10.2023 to 31.03.2024, or, till the determination of regular Tariffs for their respective control periods, whichever is earlier.

ORDER

In view of the above, the Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, hereby orders that: -

- (i) **The Independent Service Providers /Airport Operators** providing services relating to Cargo Handling/ Ground Handling/ Supply of Fuel to the Aircrafts at the various Major Airports as listed in Table 1 above, are allowed to levy the existing tariffs, applicable as on 30.09.2023, for a further period of six (06) months **w.e.f. 01.10.2023 to 31.03.2024**, or, till the determination of regular tariffs in respect of their respective control periods, whichever is earlier.
- (ii) The Airport Operators shall ensure timely submission of MYTPs by the concerned Independent Service Providers operating at their respective 'Major Airports'.
- (iii) The Airport Operators to ensure compliance of this Order.
